


**Advisory Board: Welcome and Bye-bye**

#### **RESOURCES AND INITIATIVES**

Discover initiatives and tools to support and empower children across Europe. From events to resources, there's something for everyone to learn, participate in, and benefit from:

- **Platform resources:** New documents and translations have been added to the <u>document library</u>. This includes:
  - Child-friendly version of the Recommendation on child protection in all EU languages
  - Child-friendly summary of the Democracy survey results in all EU languages
  - Child-friendly report of the Create, Plan, Participate 1<sup>st</sup> working meeting
- <u>Jericho campaign</u>: Co-funded by the European Union to help young people recognise risky situations and learn how to protect themselves. The project produced creative content for children and adults: <u>videos</u>, <u>web</u> <u>series</u>, a <u>flyer</u>, and <u>podcasts in English</u>, <u>French and Italian</u>.
- New EU youth advisory panel: The EU agency for Fundamental Rights
  (FRA) is setting up a pilot youth advisory panel with young people aged
  from 18-25. Applications are open until 9 February.
- Al in STEM Challenge: Science on Stage Europe is inviting primary and secondary STEM teachers to work with their students to produce poster or short video of an innovative approach to using Al. Winners will go to Berlin in June 2025 to present their projects. Get more details and apply by 23 February.
- 5Rights Foundation: This international foundation provides resources and tools on children's online rights, including <u>child-friendly information</u>.
   Children from the age of 13 can apply to join the <u>Youth Ambassador</u> <u>programme</u> for youth-led activities to empower young advocates to make their voices heard.
- European Youth Event: On 13-14 June in Strasbourg, EYE brings together 16- to 30-year-olds to debate directly with Members of the European Parliament and other EU decision-makers, and to exchange views with

experts, activists, and content creators. Registration opens in February.

- **European Youth Portal**: Visit the <u>Youth Portal website</u> for information on events, activities, and networks for youth in different EU countries on lots of different topics.
- **Safer Internet Forum 2024**: The Forum was held in November under the theme of child protection and inappropriate online content. <u>Click through to watch the video recordings</u>.
